- Water Bottle Filler/fountain for DB lower level: \$3000.00 @ the most for cost we are presently waiting for the school to respond regarding working with us to get a new water bottle filler in place of the present water fountain that has not been working for several years.

## **NEW Business:**

- Apthorp Dugouts: Both have been ripped down \$150 for demolition slabs are left in contact with the school regarding time for replacement and reconstruction.
- Event Contracts: Policy & procedure Discussion
  - \* we will be doing some research by looking at some local area recreation centers Conway, Newmarket & Claremont
- P&R Director Search: Letters were sent to the top five candidates for Park & Recreation Director explaining the situation with the town vote and the need for a Town Manager, etc.
